--Motion made by Councilor Laflamme to receive and pass. Councilor Laflamme stated at 5:30 had a presentation on lock boxes. Discount price, box can be put on a residence for emergencies. Well-being checks are over one thousand per year. Don't have to break in, this key is a special key held by police and fire to allow access to the box. People want to get involved in this program. Councilor Roy stated there will be more than one key, one per truck, one per ambulance. Councilor Tillotson stated the box cost about \$45.00, the city is charging \$15.00, can pay when the box is delivered. Won't have to break a door or a window to get in. Fire Department found a way to buy the boxes. Councilor Laflamme stated the Fire Department will check safety of home while they are there. Great program. Motion passed through all stages by a unanimous roll call vote. Councilors Brooks and Dobosz absent.
