# Connecticut Riverwalk & Bikeway Neighborhood Meeting Notes December 18, 2014

- ❖ Mayor proposes second community meeting in 3-4 months
- Consider alternative meeting place for additional seating
- ❖ Blue Light Phones Talk to Elms College for additional information on the campus system
- Emergency Access Mile markers and street names for easy access in case of trail-users needing to call in a medical emergency
- \* City will accept this project upon completion and City inherits control and maintenance
- ❖ Maintenance of the levee system ongoing by Department of Public Works (DPW) and Flood Control
- ❖ Army Corp of Engineers (ACOE) has been and will continue to be involved in the design process they have approved plans and concepts to date
- Massachusetts Access Board can approve variances to ADA accessibility requirements
- ❖ Any design issues to allow use for snowshoeing and cross-country skiing?
- Birding/Hand Cycles?
- ❖ Driving Range
  - Liability & Safety
    - Currently has a 45-foot screen and wind does not allow for a taller screen
    - Calls police regularly to report issues
    - Crime with kids on bikes
- ❖ Why not put the whole bike path on top of the dike?
- ❖ Will there be enough parking? How much parking will there be? 100 spaces?
- ❖ How many people are going to use this bike path?
- Homeowners and tax payers:
  - o ACOE issues for recertifying the dike and flood insurance requirements
  - o What is the grading? Will there be impervious surfaces?
  - o Review of ACOE Section 408 permitting process
- Concern regarding the hydraulic study analysis
  - O What sort of flood control measures are in place?
  - o What security and safety measures will be in place?
- Police Call Logs
  - 22% of calls were from Willimansett
  - o 22% of calls were from Chicopee Center
  - Review of planned parking by police staff
- Maintenance
  - O Bikers who do not like path will they cause graffiti and disrepair?
  - Bike path in Chicopee Center
    - Will there be graffiti issues?
    - Will there be ADA accessibility?
    - Will it be open all year?
    - Is it saving commuters anything?
  - O Why are issues from August not addressed? Including:
    - Risking the loss of the driving range

- Will there be bathroom facilities on the path?
- Where are meeting notes from the August meeting?
- Why are we building something for just families?
- What is the bigger picture? Is this going to be regional?
- It is already very unsafe on Chicopee Street
  - Sand under bridges at Chicopee Street
- Add bike paths on roads make roads more bike accessible
- Why not wait for all pieces for regional system?
  - Make a road connection
- 1998 report is through 2014 this data may be out of date
  - Supply updated reports
- Residents do not want anything on top of the dike
- Online presentation when will online information be made available to the public?
- ❖ Why access on Paderewski?
  - O Concern about increased traffic
  - o Maybe add sidewalks in this area first? There are many safety concerns
  - Access at Paderewski why? It is not necessary
- Police Patrols there are none currently. Can this be implemented sooner than completion of the bike path?
  - o Why did police have dirt bikes/motorcycles?
    - Chief addresses why police are not using their dirt bikes
    - Homeland security does not give the City these vehicles
- ❖ What is this going to cost to maintain?
  - o Impact to tax rates?
  - Maintenance adds to DPW/Park responsibilities
    - It is a burden, however, departments can accommodate the requirements
  - O Streets typically last 15 years with heavy vehicles, this should last much longer than a typical roadway
- Concern by abutter with vacant cars and they have been fighting for a year and a half to have this addressed – send to Problem Properties Committee
- ❖ ACOE resident would like to see a representative from ACOE at one of these meetings
- ❖ Are residents allowed to walk the levee now? -- Yes
- ❖ Paderewski Street Oldest street/ near sewage treatment plant "quaint neighborhood"
  - o Deal with summer odors
  - o Trucks
  - Dead-end streets
  - o "Additional traffic"
  - o Parking under high tension wires
  - o Syringes/waste/litter
    - Trash receptacles/lighting
  - o Cars coming in from other cities
  - o Residents are neighbors who know one another and are afraid of new people being in the
- \* Resident thinks this project is wonderful:

- o Concerned about parking but she sees this as a neighborhood facility
- o Concerned about trash
- This will be better for families and take kids off the streets, addresses kids and safety concerns
- ❖ Overlooks why is one located near Freedom Street?
  - o Similar project in West Springfield as well
- ❖ Will there be gates at entrances? –Yes, gates will provide pedestrian access and will be functional to allow maintenance vehicles to access the area
- ❖ ACOE can the project be rejected later even with initial approval?
- Portal (can a ceiling cover be installed to protect users from golf balls)
- Clark Street break ins (cars, sheds, etc.)
- ❖ Lack of trust towards police
- ❖ Cameras? -- Why only proposed at each end?
  - Spotters and radios to keep themselves informed
- Nash
  - Pumping station used as hang out
  - o Drug dealers leaving drugs in the wall and selling them there
  - Murder threats
  - Undesirables at Nash Field
- ❖ Good asset; want a safe place to walk and bike with her children
  - o Drivers are not following speeding laws and crosswalks
  - o It will reduce crime
  - O Tax payer sees this as worth the money
  - o Nice and safe once it is built
  - Reference to Easthampton project
- Sees effort being put into project
- ❖ One major flaw Perception that the majority of residents do not want it
- Easthampton
  - "Not In My Back Yard" Easthampton residents had the same concerns and once built, none of those concerns were realized
    - This will be good for Chicopee
- Main purpose of the levee and its future protection to the neighborhood
  - O Severe storm events in the valley...massive flooding potential
  - Pioneer Valley Planning Commissions (PVPC) seems to be pursuing "massive greenway projects"
    - Last people they talk to are residents and landowners
    - Hearings are good but the process is "messed up"
  - o Federal Emergency Management Agency (FEMA) zone and risk calculations
    - New Orleans Changed zones
      - 7 zones to 3 zones
  - Conversation at Chicopee High School
  - o Major concern with flooding events
  - O August 6th meeting resident comments have been documented
- ❖ Committee for Bike Paths there was a committee for Chicopee Canal Walk
  - It is a City asset to have a riverfront along two rivers

- O We do not take advantage of our natural resources
- Other cities across the world use these amenities
- o Great for the neighborhood north of Chicopee River
- Establish Chicopee Bike Path Committee
  - o Improve communications with the community
- Give this a chance to move the City forward
- ❖ DPW questions parking on street is it one-side only?
  - o Add new parking signs?
- ❖ Medina Street Boat Ramp
  - O Concern over high tension wires users of the boat ramp have been ticketed by the City for parking under the high tension wires during seasonal fishing derbies
  - o Review design process
  - o Add to ballot for entire city?
  - o Already burdened by pump station/etc.

#### Other Comments:

- Springfield Bike Path and Safety Concerns
  - o Concrete wall at Plainfield Street
  - Riverfront Park example
  - o No criminal acts
- **❖** Bonner Street
  - O Last meeting was a disaster nice to see this is a civil meeting
  - Would not drive to another community for 2.5 mile trail. Not likely to attract significant number of outside visitors
  - This will be used by the neighborhood
    - Safe place to play for neighborhood children
  - o Northampton's bike path is 22 miles and caters to a different group of people
  - o Cleanup Committee to keep the trail clean
- Graffiti/Trash on the Chicopee Center path
- ❖ Possible civilian patrols?
- ❖ Maintenance concerns about maintenance and who is responsible?
  - o Flood control
  - Parks
  - o DPW
  - o Parks are not being cleaned now
    - Skateboard park is messy
- ❖ Agawam and Springfield these trails abut streets
  - Willimansett is not like Northampton
  - o Privacy concerns for direct abutters' backyards
- Understands why people want this and that a shorter bike path will not draw as many people
  - Wants to see street improvements if this goes through
    - Curbs and sidewalks are forgotten at the end of streets
    - Upgrades on Paderewski there is no room for parking
  - o People will still live here
- ❖ 109 Ferry at Nash Park
  - o Added activities and people at Nash

- O This is a small neighborhood that has suffered some crime and does not want crime to escalate again
- O We do not know what type of riders are going to be on the bike path
- o Nobody really knows what this is going to do
- Provide Hydraulic study to the website
- Parking
  - o Still concerned about people coming from outside the City
- Petition of 266 signatures and is ongoing
- \* This meeting is great but poorly timed and too close to the holidays
- People need questions answered
- ❖ People already pick up litter when retrieving golf balls
- Safety concerns
  - O Don't feel safe walking around at night
- ❖ Take care of what we have now
  - o Sarah Jane Park
    - Path there is bumpy
- \* This will put the golf course out of business
- ❖ Accept a good thing and then meet to address complaints

#### Resident #1

- Parking at Nash Park is already insufficient for games, etc. No mention of parking plans at Nash Park?
- ❖ Maintenance Chicopee cannot keep current parks in proper repair, i.e. pools at Rivers Park and Nash Field. How can we afford to maintain added areas?
- ❖ It sounds like we are going forward with this regardless of what people want.

## Resident #2

- Erecting a fence along the Connecticut River for safety issues?
- ❖ Making an effort to keep the levee clean more than 4 times a year. The trash comes up the street on windy days − constantly clean-up every day!
- ❖ Fire Department needs to control fires; especially during summer months that individuals illegally burn from the neighborhood if I am walking I don't want to smell smoke!!!

- They do not keep the levee mowed now. What makes anyone think they will start mowing more because of a bike path? I'm sure it will deteriorate in time.
- ❖ They did not spray the levee until late this summer. People will not want to use the levee if it is too buggy.

❖ I think the City will have to pay for the upkeep once the Feds stop. It seems to be an awful lot for a very short distance. No wonder we are trillions in debt.
