TRAVELERS' RULES OF OPERATION FOR ALL TRIPS

- There are no trip sign ups before the scheduled opening at the Senior Travel Club Open Meeting. Mail reservations for **unopen trips** will be processed at the conclusion of the monthly open meeting.
- A non-refundable deposit (usually \$10.00) is required for all trips. Some trips may require a larger deposit. The balance is due by the date posted on the flyer.
- No reservations will be accepted by phone.
- Bus seats will be assigned at the time your trip is paid in full. To hold an adjacent seat, one partner must have made full payment and made a deposit for second traveler.
- All checks are made out to: **Chicopee Senior Travel Club.**
- If sending payment by mail, be sure to include your **name, address (including ZIP), phone number, cell number, name of the trip and meal selection** if applicable. If paid in full, bus seat is assigned by planner.
- Refunds for paid trips can only be made if a vendor has not been paid by the club or a replacement has been found. Each traveler is responsible to find his/her replacement. However, we will maintain a wait list to help in this effort. Refunds do not include the non-refundable deposit.
- The current status of events can be determined by visiting, calling or e-mailing the Travel Club. The RiverMills Reminder is issued every other month and an event could be wait-listed before it appears in the latest issue. **Phone # 413-534-3642 X113**
